### The Challenge

Any implementation of a new enterprise application, such as Workday, requires data from legacy HCM systems to be migrated into the new environment and data structures.

Most organisations are not fully aware of the scope and magnitude of a large and complex migration challenge such as this. As with any new application, the target data structures and rules are usually significantly different to those of the legacy sources, and thus the data migration process requires extensive data manipulation and transformation.

Furthermore, legacy data is frequently fraught with data quality problems that need to be remediated before going live with such data in the new Workday environment.

Also critical to a successful data migration are processes that effectively deal with source to target data reconciliation and full auditability.

Whilst an implementation partner may be appointed by the client to implement Workday, typically it is the client who would be responsible to execute on many of these data related requirements. Also, the implementation partner does not usually take responsibility for addressing legacy data quality issues.

Ultimately, therefore, it is Workday clients who are wholly responsible for providing all the data and also ensuring it's quality – this is no small task!



Additional Considerations:

- Clients, not knowing or understanding the whole data migration process required for a Workday implementation, will typically not have a properly structured approach and thus make mistakes that require rework, resulting in wasted time and effort, budget and time overruns, and overall a sub-optimal implementation.
- The first tenant requires data immediately. Clients are often not prepared due to, for example, lack of staff availability, platform constraints and the skills needed for the data migration.
- Frequently an associated payroll system replacement also takes place alongside the Workday implementation, adding complexity to the interrelated data migration effort.

## The Solution

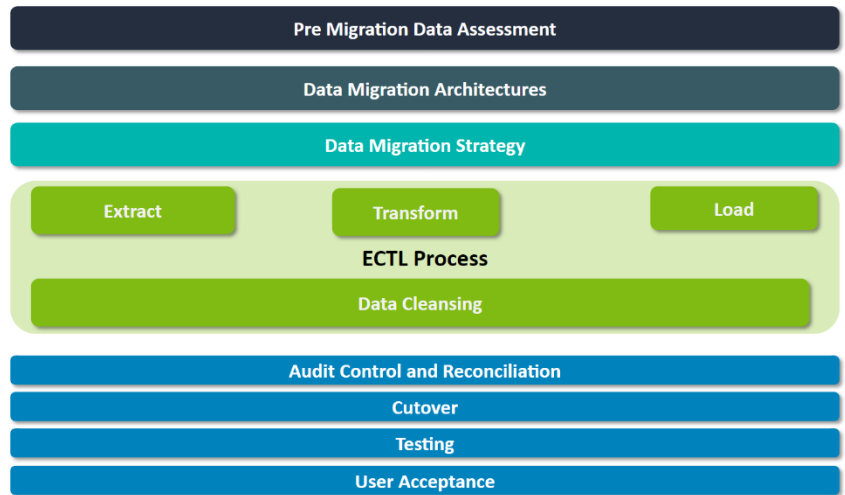


Figure 1: The InfoBlueprint Data Migration Framework

InfoBlueprint have developed a tried and tested Data Migration Methodology. The Methodology is based on our Data Migration Framework (Figure 1), which defines all the components we believe to be important when migrating data. We start with a Pre-Migration Preparation Process, which includes developing a Data Migration Strategy and a Data Assessment of the legacy data if necessary.

The Data Migration Strategy defines the Scope of Data to be migrated and the approach in terms of the Extract, Cleanse, Transform & Load (ECTL) and the Supporting Processes. The ECTL Process is the main Data Migration Process. The Support Processes are integral parts of each of the ECTL Processes. This results in the assurance that the Data Migration Process is auditable, tested, and also fully enabled for both cutover and user acceptance.

We advocate an iterative approach to Data Migration. The approach must be automated, productionised, and should require minimal human intervention.

## Our Typical Data Migration Architecture for Workday

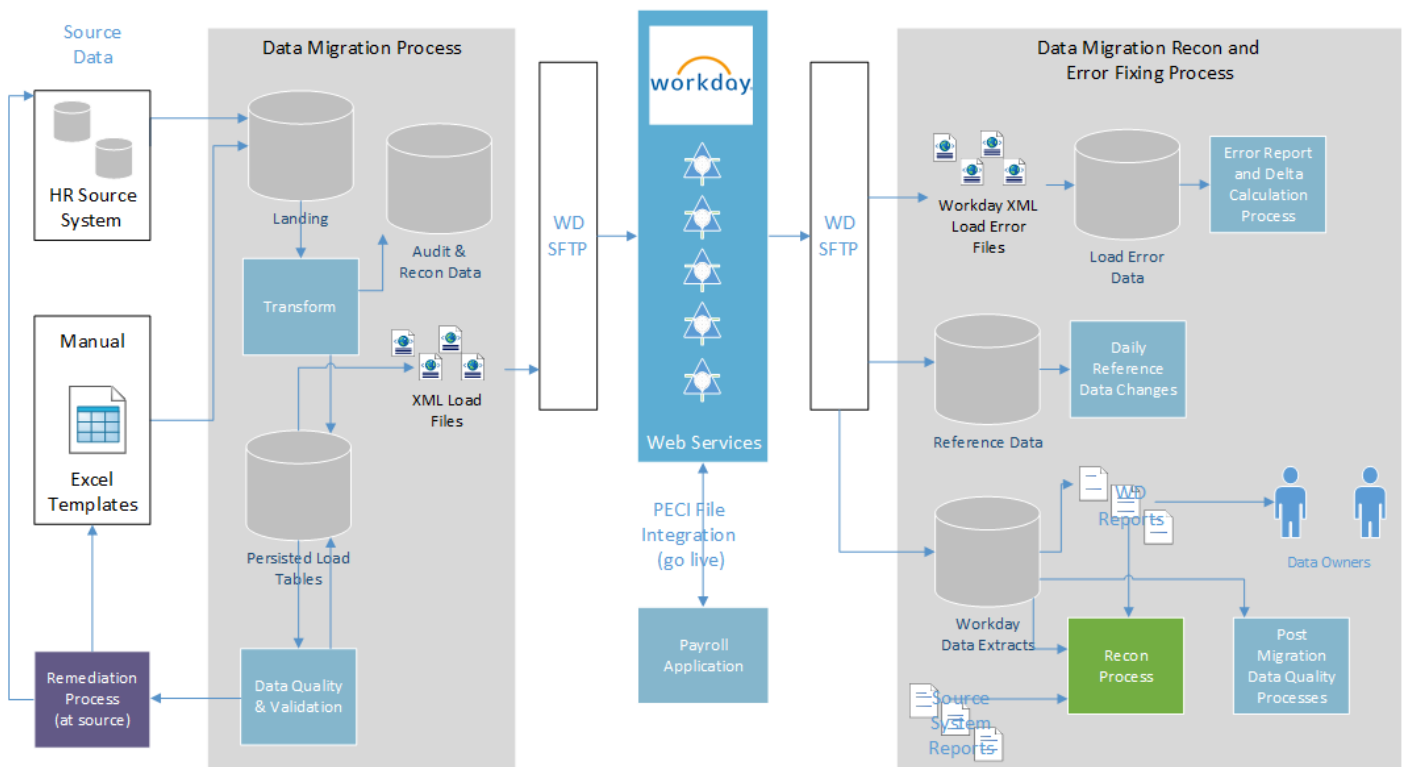


Figure 2: Typical data migration architecture for Workday

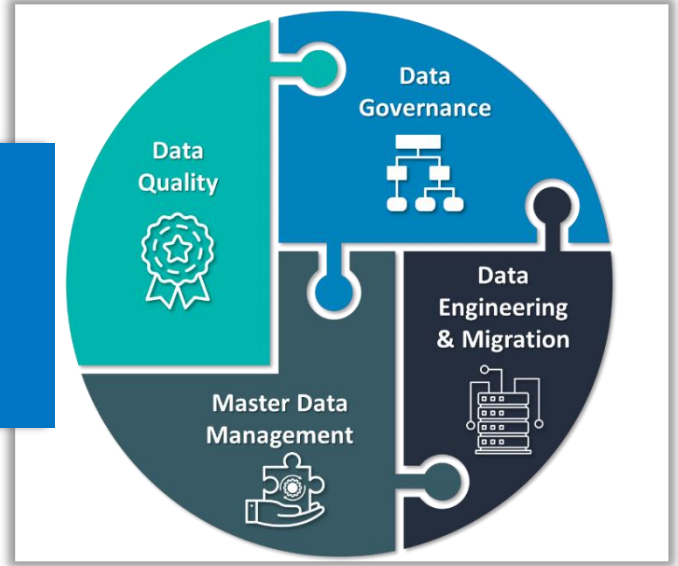

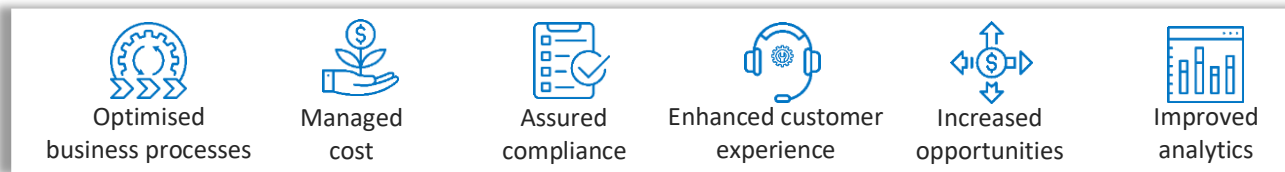
